Detailed description of project

The **specific objective** was to support the Ministry of Justice in its efforts (i) to strengthen the judiciary on commercial cases, (ii) to strengthen the respective training of judges and lawyers and (iii) to ensure that the national legislation on commercial issues is harmonised in line with EU standards and best practices.

The following results were achieved:

- An Implementation Action Plan (Legal) including short-, mid- and long-term measures as well as benchmarking and monitoring mechanisms for improvement and harmonisation of the current legal framework elaborated and selected measures implemented;
- An Implementation Action Plan (Institutional) including short-, mid- and long-term measures as well as benchmarking and monitoring mechanisms for (i) improvement of the working methodologies, i.e. the organisational structures (workflow processes) in commercial issues, and (ii) adjustments of the IT-supported Civil Case Management Information System (CCMIS) elaborated and selected measures implemented;
- Cost & benefit analyses on (i) the budgetary impact of the legal approximation process on commercial issues and (ii) the budgetary impact of the institutional approximation process on commercial issues accomplished;
- Legal advice in the legal drafting process provided;
- An on-line library set-up;
- An EU 'best practices' manual on working methodologies, i.e. the organisational structures (workflow processes) in commercial issues elaborated;
- Adjustments to the IT-supported Civil Case Management Information System (CCMIS) undertaken;
- A total of **20 future trainers trained** following a 'Training-of Trainers (TOT)' approach;
