Detailed description of project

Type of services provided

EURALIUS II built on and further strengthened the results achieved in the preceding project i.e. EURALIUS I. In this respect, the **specific objectives** were (i) to review constitutional provisions, the check and balances of judicial powers and proper functioning of this principle, (ii) to enhance the inter-institutional dialogue and cooperation between the Judiciary, the Ministry of Justice, the General Prosecutor Office, the Ministry of Interior, the Albanian State Police and related stakeholders, (iii) to improve the organisational, administrative, planning, and resource management capacities of the Judiciary and of the Ministry of Justice, (iv) to improve the planning and financial management systems of the Office for the Administration of the Judiciary Budget, (v) to improve the quality of the legal drafting process and to improve the capacity and raise awareness of the EU Acquis, (vi) to further strengthen the capacity of the General Directorate of Prisons, (vii) to raise the enforcement rates of judicial rulings in Albania to average EU levels (viii) to increase the transparency and efficiency of the judicial process, (ix) to improve the legal framework and efficiency of criminal justice institutions, and (x) to support the improvement of the technical and legal framework in the area of land administration and immovable property rights in Albania.

The following **results** were achieved:

- legal drafting process enhanced, the awareness of the EU Acquis raised, and the political decision taking processes improved
- a sustainable strategy for reforming the justice system elaborated and its implementation started
- judicial system improved, made more transparent and more efficient
